## Webinar on Proposed Changes to the Community Reinvestment Act

The Trump Administration is considering an overhaul of the Community Reinvestment Act (CRA). On September 1st, the Office of the Comptroller of the Currency's (OCC) issued an Advance Notice of Proposed Rulemaking (ANPR) regarding the CRA. The notice provides 75 days from the date of publication for public comment on 31 questions designed to suggest possible changes to the CRA regulatory framework, which was designed to encourage financial institutions, namely banks, to help meet the credit needs of the communities that they serve, including low-income neighborhoods and underserved people.

The National Development Council (NDC) will be hosting a webinar to provide background on CRA and then pose a series of questions to three experts concerning proposed changes and their points of view on CRA modernization.

The webinar is being held Tuesday, September 25 at 3 PM EST.
