Dear Mr. President and Members of Congress,

The New Markets Tax Credit (NMTC) program, an important source of financing for businesses and community development projects, expires in 2025. The NMTC Coalition and the undersigned organizations urge you to pass bipartisan legislation and make the NMTC a permanent part of the Internal Revenue Code.

The NMTC has a twenty-year track record of financing small businesses, daycare centers, health clinics, manufacturing expansions, workforce training programs, broadband expansions, schools, recreational facilities, clean energy projects, and other revitalization projects that strengthen communities and generate long-term economic growth. To date, these new investments have created over 1,000,000 jobs in distressed communities across America.

Each year, the NMTC finances hundreds of projects creating over 50,000 jobs in urban and rural communities. Tight competition for credits pushes NMTC investments toward high impact projects in the most distressed communities in the country. Community development organizations target the creation of quality jobs with good benefits, most of which are accessible to existing residents of distressed communities.

The NMTC is not only positive for our communities but has economic benefits for the federal government. Each dollar of federal investment leverages public-private partnerships to stimulate a total of eight dollars of investment in areas of distress. Through this innovative model, the federal government incentivizes private sector involvement, ensuring sustained economic growth and development in areas that need it most.

We strongly support making the NMTC permanent by passing the bipartisan NMTC Extension Act (S. 234 and H.R. 2539). In addition to extending the program at \$5 billion in allocation per year, the legislation would provide an inflation adjustment for future years. It also includes reforms to ensure the NMTC program maintains its efficiency during an economic downturn when it is needed the most.

Please ensure no community is left behind and preserve one of the federal government's most successful community development programs.
